#### PURPOSES OF THE NATIVE TITLE HOLDERS MEETING

The purposes of the Native Title Holders Meeting is to:

1. Consult with and obtain the consent of the Kullilli People common law native title holders with respect to the Kullilli Bulloo River Aboriginal Corporation RNTBC (**the PBC**) entering into landholder agreements that confirm the PBC's eligible interest holder consent under Section 28A of *Carbon Credits (Carbon Farming Initiative) Act 2011* (Cth) in relation to Carbon Farming Projects at Thargomindah and Wathopa Station.

The parties to the project at Thargomindah Station is Kullilli Bulloo River Aboriginal Corporation RNTBC as the Lessee and Kullilli Bulloo River Aboriginal Corporation RNTBC as the Proponent and Climate Friendly as the service provider.

The parties to the project at Wathopa Station are Kullilli Bulloo River Aboriginal Corporation RNTBC as Native Title Holders, Wathopa Pty Ltd as the landholder and Climate Friendly as the service provider.

2. Approve standing instructions decisions to be made by the PBC in accordance with Rule 12.4 of the PBC's Rule Book to allow the PBC to enter into further landholder agreements, including provision of eligible interest holder consent, for other properties with Climate Friendly Pty Ltd and other landholders on terms to be decided by the Kullilli People common law holders at the Native Title Holders Meeting.
